As Councillor Paddy O'Rourke obtained 13 votes, which was the majority of the members present and voting, the proposal to elect him as Cathaoirleach succeeded and consequently the proposal to elect Cllr Padraig Fallon as Cathaoirleach was defeated. Mr Kieran Brett deemed Cllr Paddy O'Rourke elected as Cathaoirleach for the year 2024/2025.

Councillor Paddy O'Rourke thanked his proposer and seconder. He congratulated everyone who got elected and secured a seat on the council at the recent elections. Councill O'Rourke said he was pleased to see that all the 12 outgoing members who sought to be reelected were re-elected comfortably and he said that this says something about the view the public have on the way they are operating the Council. Councillor O'Rourke said there are not many other counties where all of the outgoing members who sought re-election were returned by the electorate, and he said this is a testament to the calibre of the people who sought to be re-elected and were duly re-elected. Councillor O'Rourke welcomed the six new elected members and he wished them every success for the next five years.

Councillor Paddy O'Rourke complimented the professional way in which the Local Election count was conducted and was complimented the count staff for their work and professionalism. He said the venue for the Election Count was excellent.

The members congratulated Councillor O'Rourke and wished him every success as Cathaoirleach for the forthcoming year.

Councillor Mary Bohan rebutted the allegations made by Councillor Des Guckian and she said some of the remarks made are not fair to staff and elected members. Cllr Bohan said if all members were to take the approach of walking out of meetings, a Commissioner would be put in place to run the Local Authority.
