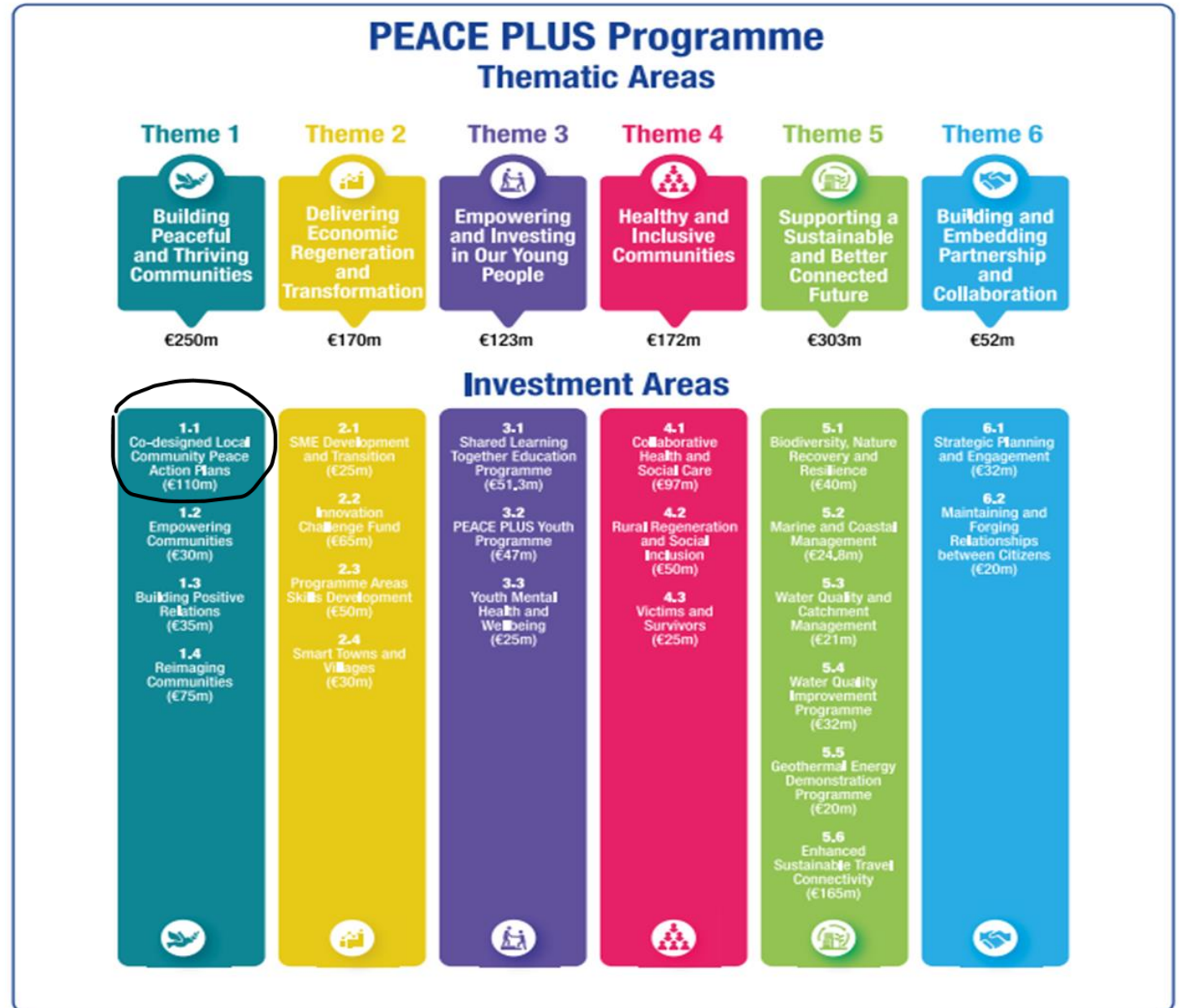

- ❑ Help build the strength and capacity and inclusion of those with a non-verbal disability to engage in a wider number of arts activities across the county.

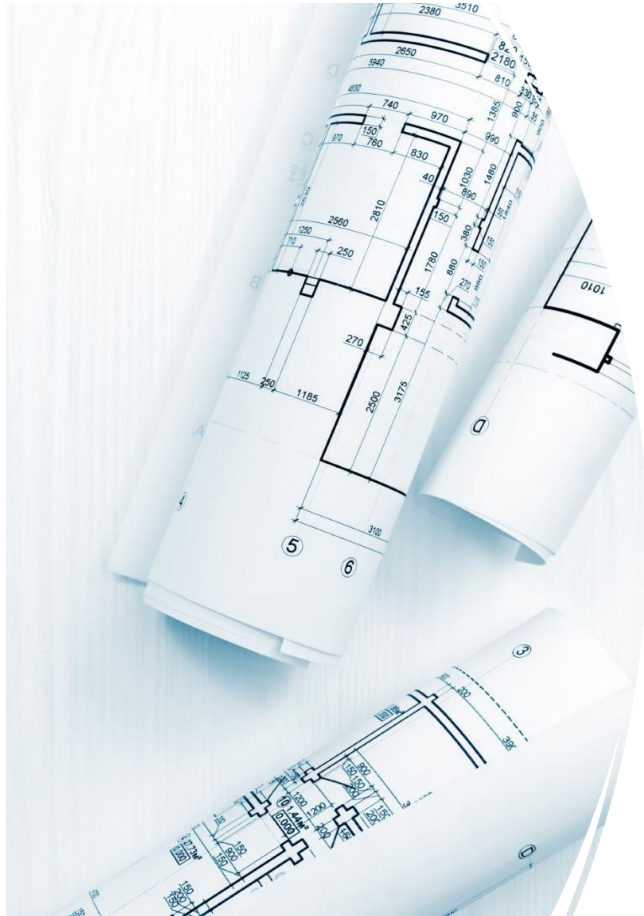

RFT & Terms of Reference



- Important to understand project requirements
 - Participant numbers for activities
 - Overall minimum hours required
 - Cross Community & Cross Border targets e.g.
 - Maximum budget must be adhered to
- Ensure you have a clear understanding of what has been specified and what is required. If there anything that is unclear request clarification through the eTenders messaging system.
- Respond fully to each section of the tender, providing relevant evidence where required – especially important for Stage 1 Assessment requirements

TRD – Tender Response Document

Open Procedure

- Tender process where any interested supplier or contractor are allowed to submit a tender bid. This procedure is often used in public procurement to ensure transparency, fairness, and competition in the acquisition of goods, services or works.
- This procedure involves a 2-stage assessment approach with only those demonstrating that they have the required level of financial and technical capacity at Stage 1: Selection Criteria of the assessment will proceed to have their tenders considered for Stage 2: Award Criteria

Stage 1 Assessment – Pass fail Criteria

- General company info
- Tax details
- Insurances
- Previous experience
- Declarations

TRD – Stage 2: Assessment: Award Criteria

Criterion A

- How project activities will engage & work in different communities?
- Identify how/where/why participants will be recruited from
- How will it be a cross community project?
- Potential for cross border cooperation
- Equality, Accessibility & Charter of Fundamental Rights of the EU – is the project allowing participants to be treated with dignity, freedom, equality, solidarity, citizen’s rights
 - Does a venue have disability access and have activities been planned taking into account the needs of those with a disability?
 - Language – translation & interpretation
 - Timing of activities around school times, childcare etc
 - Catering for diversity
 - Free programmes – reduces barriers for those on low incomes & areas of high deprivation

Sustainable Development

Criterion A

- All projects must contribute positively to the horizontal principles – Sustainable Development is one of these. Refer to the [UN Sustainable Development Goals](#) . Pick 2 or 3 of these and write about how your project helps those.
- **Environmental Sustainability**
 - Swap paper for digital
 - Merchandise – is it necessary? Is it sustainable? Opt for reusable
 - Venues accessible by public transport
 - Provide recycling bins
 - Catering - Avoid single use plastics (cutlery, drinks bottles, straws)/ Use re-usable crockery/ Use local caterers & produce/vegetarian/vegan options/ donate left-over food/ composting food scraps
 - If your organisation has ‘Sustainable’ or ‘Green’ policies please refer to them

Sustainable Development

Criterion A

- **Social Sustainability**
 - If you are a community / not-for profit organization, winning the tender helps to sustain your work – that is social sustainability e.g. working with community groups to deliver on projects can enhance their project management skills, groups have gained new knowledge, skills & confidence
- **Economic Sustainability**
 - Building capacity can help community groups/initiatives gain further funding
 - Participants can gain qualification allowing them to enter the job market
 - Employees can gain new skills which can open up opportunities for them
- Sustainable development includes environmental, economic & social. You don't have to cover them all, but you may find your project does.

TRD – Stage 2: Assessment: Award Criteria

Criterion B

- Demonstrate organisational skills, qualifications and experience for project delivery
- Requirement for dedicated resource/resources to coordinate / deliver project – evidence of how this will be achieved
- Understanding community needs, potential of partnerships to bring diverse elements to the programme
- Address each element in the ‘Project Outputs & Targets’ table included in the terms of reference – consider how each project activity will contribute to achieving the outputs, participant numbers, contact hours, cross community & cross border targets contained within
- All projects will be required to comply with the Monitoring & Evaluation process
- Communications includes a launch and close, 2 press releases & contributions to a quarterly newsletter compiled by LCC

Monitoring & Evaluation

- A Monitoring & Evaluation Officer will be appointed by LCC to ensure all projects are meeting project requirements
- Data will be required on cross community/gender/ethnicity of participants
- Templates will be provided by LCC
- Participant outcomes will also be evaluated through completion of questionnaires before & after project activities to track attitudinal change.
- These will include 5-6 questions (subject to approval by SEUPB)
 - Has this project allowed you to meet people from different identities?
 - Has this project helped you connect with new places and/or identities?
 - Has this project increased your understanding and respect of other cultures, identities and opinions different from your own?
 - Has this project made you more open to participating in other peace building, cross community/cross border activities?
 - Will you/have you spoken to other people about this project and what you have learned?
