### Roads Act 1993

**Temporary Closing of roads**

In accordance with the provisions of Section 75 of the above Act and Article 12 of the Roads Regulations 1994 and for the purposes of Public Realm Improvement Works, Notice is hereby given of the intention of Leitrim County Council to make a decision to close the following public roads in the Carrick on Shannon Municipal District-

1. L3413 (Summerhill, Carrick on Shannon) - from the junction with R208-1 (Kelly's corner on the Dublin Road) to a point 70m North of this junction on the L3413.

Two-way traffic will be permitted for the duration of proposed closure period to allow access for residents and businesses on the L3413, with the access from the eastern end (Hospital End) of this Local Road.

The alternative route: Traffic will be diverted via the Old Dublin Road to the Shannon Roundabout on the N4 and then east along L3412-1 (Circular Road) and then North along L3412-2 where they can access Summerhill.

2. L3399-2 (Quay Road) from the junction of the L 3399-1 (St. George's Terrace) to the junction with the L3399-4 (The Quays).

Local access will be maintained for residents living along this section of Quay Road and arrangements will be made to facilitate deliveries to businesses. Two-way traffic will be permitted along this section of Quay Road for the duration of this proposed closure period.

The alternative route: Traffic will be diverted via L3399-4 (The Quays) onto the N4 to the Shannon Roundabout and then North onto the Old Dublin Road and east along Main St to the Town Clock junction where they can access St. George's Terrace.

The proposed closures commence on Thursday the 19<sup>th</sup> August 2021 and are required until Sunday the 29<sup>th</sup> August 2021.

Any person aggrieved by the proposed decision to close the road described, may lodge an objection with the Director of Services, Economic Development, Planning and Infrastructure Services, Leitrim County Council, Aras An Chontae, Carrick on Shannon, on or before 12 Noon on Wednesday 11<sup>th</sup> August 2021.

### Roads Act 1993

**Temporary Closing of Roads**

In accordance with the provisions of Section 75 of the above Act and Article 12 of the Roads Regulations 1994, and for the purpose of facilitating planned maintenance works to Drumloughan Approach Bridge, notice is hereby given that Leitrim County Council proposes to make a decision to close the following section of public road in the Ballinamore Municipal District.

Local Road L-5561, either side of the Drumloughan Approach Bridge.

The local road L-5561 will be closed from 9<sup>th</sup> August to 16<sup>th</sup> September 2021 to facilitate rehabilitation works to Drumloughan Approach Bridge. Leitrim County Council will endeavour to expedite the works process in order to open the road sooner.

Diversion will be in place via L-5579 Annaghmacullen and R-201 Cloone, with local access only as far as Drumloughan Approach Bridge.

The alternative routes:

Travelling from Cloone to Annaghmacullen - continue on R-201 and turn right off the R-201 onto the L-579

Travelling from Annaghmacullen to Cloone - turn right off the L-5561 and left onto the R-201 to Cloone

Diversion will be signposted.

Any person aggrieved by the proposed decision to close the roads described may lodge an objection with the Director of Services, Economic Development, Planning & Infrastructure Services Leitrim County Council, Aras an Chontae, Carrick-on-Shannon, Co. Leitrim on or before 4.00 p.m., Friday 30<sup>th</sup> July, 2021.
