Notice is hereby given that Leitrim County Council, proposes to carry out the following works at Main Street, Drumsna, County Leitrim:-

Construction of a 2 storey Apartment building to consist of 2 no. 1 bed units at ground floor and 2 no. 1 bed units at first floor located at Main Street, Drumsna, County Leitrim. The proposed development will also consist of new site entrance, car parking spaces, boundary wall/fence, footpaths, private open spaces, bin storages, landscaping, formation of new connections to existing foul/surface water drainage and existing utilities and all associated site works and services.
