Part 8 Public Notice Pursuant to the Planning and Development Regulations 2001 (Article 81) as amended.

Notice is hereby given that Leitrim County Council proposes to carry out the following works at Drumshanbo Narrow Gauge Trail.

1. Creation of a pedestrian crossing on Dowra Rd (R207).
2. Upgrade of unused narrow gauge railway to a walking/cycle trail.
3. Creation of an uncontrolled pedestrian crossing on Convent Avenue.
4. Creation of new trail to join railway line to the Ballinamore Rd (R208).
5. All necessary ancillary works.

The proposed development is located adjacent to 1 no. protected structure on the Leitrim County Council Record of Protected Structures (RPS Reference No. 82) comprising of a bridge structure associated with the former Cavan – Leitrim Railway. The proposed development will not materially affect the character of this protected structure.

No. 296 of 2018), Leitrim County Council has concluded that the proposed development does not require an Environmental Impact Assessment and will not be likely to have a significant effect on the environment. Any person may, within 4 weeks from the date of this Notice apply to An Bord Pleanála for a screening determination as to whether the development would be likely to have significant effects on the environment.
