Mohill Painting Scheme 2025

Leitrim County Council is launching a Mohill Painting Scheme for 2025 to provide financial support to businesses and residents for painting the front of their properties. This initiative aims to enhance the aesthetics of Mohill and create a more vibrant and welcoming environment for the community and visitors alike.

Programme Overview

The painting scheme provides financial aid for property owners to improve the exterior appearance of their premises within the designated town centre area (please refer to the approved area map contained in appendix 1).

Eligible participants include:

- Businesses and commercial premises
- Residential properties

Only properties within the designated area outlined on the map will be eligible to apply.

Leitrim County Council would encourage adjacent properties to consider collaborating on their applications.

In the case of an oversubscription to the scheme priority may be given to those properties located in areas where recent public realm works have taken place.

This programme includes:

- ✓ Property Enhancement Grant Financial support for painting and improving the exterior of properties. Including cost for preparation before painting commences such as power washing and Removal of unnecessary signage, flagpoles, and wires.
- Design Guidance Advice on colour selection and aesthetics to complement the area's character

Key Dates

- Scheme opens: 28 February 2025
- Closing date for applications: 27 March 2025
- Expected decision on applications: 23 April 2025
- Completion and claim deadline: 24 September 2025











Financial Aid

- Funding: Up to 80% of project costs, capped at €2,000 per property (excluding VAT for businesses and including VAT for residential properties).
- Applicant Contribution: Minimum of 20% match funding required.
- Claim Requirements:
 - o Proof of expenditure (invoice/receipt made out to the applicant)
 - Bank/credit union statements showing the cleared transactions to the supplier
 - All claims must be submitted by 24 September 2025
 - Onsite audits may be conducted
- Grant payments will be made directly to the beneficiary's bank account via electronic funds transfer.

How to Apply

- Deadline for applications: 27 March 2025
- Applications will only be accepted through the application form provided

Checklist for Application Submission

- Completed application form submitted to mobilistreets@leitrimcoco.ie
- Photographs of the property before painting should be included with the application form
- Quotation to provide estimated cost for completion of work to be sent to <u>mohillstreets@leitrimcoco.ie</u> with your application and clearly referencing the address of the relevant property

Data Protection: Applicant data will be processed in compliance with GDPR.














Appendix 1: Map of areas eligible to apply under the paint scheme
